## SPOTLIGHT ON AREA 1 - Suzanne Scalcione

The **Zonta Club of New Rochelle** with the Friends of the New Rochelle Public Library are sponsoring a Area one clubs have continued to focus their activities on supporting, advocating for, and helping to improve the lives of women and girls in their local communities. Serving as their area director these last two years has been a rewarding experience. I am often amazed as well as inspired by their generosity of spirit and willingness to serve local women in need. The **Zonta Club of Westchester** delivered 100 pounds of clothes to 'My Sisters Place' and 5 boxes of health supplies, food, & diapers to women and children in Puerto Rico. Their recent "Night at the Opera" was a fundraising success. The **Zonta Club of New York C** has collected undergarments and clothing to donate to rescued trafficked victims. In April, the club participated in Equal Pay Day and presented a film on 50-50 Day as part of the club's advocacy efforts. The club also successfully sponsored the chartering of the new **Zonta Club of Brooklyn**. **Zonta Club of Peconic Bay** proudly sponsored Isabella Sorgi who won the District 3 Young Woman in Public Affairs Award. Recently Peconic Bay awarded their spring 2018 ESL scholarship to Olga Santangelo on May 25. The club awards the scholarship biannually to a female student in an ESL program who is studying to achieve an educational goal. The **Zonta Club of Long Island** held its annual Birthing Kit Assembly Day with 40 community residents joining club members to produce 600 birthing kits for women in Haiti & Africa. They celebrated a WOY event in May and are planning a June wine glass painting fundraiser. The **Zonta Club of New Rochelle** is trying to expand their service project of hanging domestic violence resource information in the restrooms of hospitals, libraries, City Hall, etc., by working to create a proposition for each of their council areas where they agree to have domestic violence resource information posted in public restrooms. They continue their monthly service project to feed the hungry, making lunch and distributing information about domestic violence and free legal services at Trinity St Paul Church. The **Suffolk club's** most recent activity was a fundraiser at a local comedy club that was a financial success as well as a great evening. The club members have continued their work at Madonna Heights. At the last girl's empowerment workshop the club brought in a yoga instructor to teach the residents some stress relieving techniques. They will attend Madonna Height's annual picnic and bring supplies for the girls to paint tee shirts. This year they awarded a \$1000 scholarship to one of the graduating girls at Madonna Heights. This March, **Greater Queens** held its Amelia Earhart meeting at Vaughn College of Aeronautics and awarded Katherine Inamagua a \$500.00 scholarship. Pat Latona our ZI UN/NGO Committee member spoke at Queen's April meeting focusing on local and global anti-trafficking Initiatives. They also hosted George Garland & Peg Shannon: UNA/USA/NY, and learned about their "Adopt a Future" Campaign. Want to welcome also welcome the **Zonta Club of Brooklyn** to our Area 1 family. Kudo's to Leslie Wright and her committee for all their hard work!!

## TREASURER'S LEDGER - Rosa Goldsmith

### Examination of Club Financial Records and Form 990 Reporting Reminders

Now that Fiscal Year 2017-2018 has ended, the financial records will need to be reviewed in accordance with your club bylaws or practice of an independent review. According to Zonta International bylaws, Article XIV Clubs, Section 11. Financial Oversight, the club board shall cause the financial records to be examined by a person independent of the board.

An examination includes tracing a sample of cash disbursement to paid invoices and a sample of cash receipts to bank deposits. It also includes verifying the bank statement reconciliation and proving the cash available. Although the examination provides less assurance than an audit or financial review, it is an independent review that does not require a chartered accountant or CPA. This saves time and money in finding someone to review the books.

Form 990, an IRS requirement for all non-profit organizations, needs to be filed by October 15th. Clubs can use the 990-N Postcard or the 990-EZ Form depending on their Gross Receipts for the fiscal year. If your receipts are less than \$50,000 then a 990-N Postcard can be filed.

## SPOTLIGHT ON AREA 2 - Pamela Morgan

This biennium has been one of growth and open communication for clubs in Zonta District 3, Area 2. The biennium started with each club presidents meeting in small groups as well as individually to develop a strategic plan for the biennium focused on the areas of Membership, Service, Advocacy and Public Relations with the intended outcome of providing a roadmap for them to use to guide their club's activities for the biennium. Optional areas for inclusion in their strategic plans included Fundraising and Centennial Planning. After setting goals for each area, the president then set objectives for each goal, and designed activities to meet the objectives.

Monthly conference calls were utilized to allow club presidents to communicate with each other, and with District 3 program chairs. Some of the most successful conference calls were with Advocacy Chair Bobbee Cardillo, Amelia Earhart Chair Sharon Jones, and United Nations Chair Mary Ann Tarantula.

Area 2 also successfully hosted District 3 events this biennium. The 2016 Fall Conference was successfully hosted by the Zonta Club of Southern Ocean County, and the 2018 Spring Conference was successfully hosted by the Zonta Club of Trenton/Mercer. Both events were well attended, with attendees reflecting that the events were valuable.

Activities surrounding the 16 Days of Activism and our Amelia Earhart commemoration were central to our work this biennium. Clubs throughout Area 2 used innovative ways to commemorate the 16 Days of Activism Against Gender Based Violence during the biennium. Activities were as varied as using social media to post one activity per day for each of the 16 days, to participating in the White Ribbon Campaign to invite men to take a stand against gender based violence, to a film series focused on screening films with accompanying discussions to raise awareness on this important topic. Under the guidance of District 3 Amelia Earhart Chair Sharon Jones Area 2 clubs came together this year at the Newark Liberty International Airport to commemorate the legacy of Zontian Amelia Earhart with a film screening and lecture by a Smithsonian Museum curator. Some clubs commemorated Amelia Earhart with individual activities in 2017.

Innovative fundraising activities allowed Area 2 clubs to raise tens of thousands of dollars to finance both local service projects, as well as service projects sponsored by the ZI Foundation. Club presidents generously shared the methodologies followed for the development of their service projects with other clubs for replication.

Membership continues to present challenges to Area clubs. Many Clubs hosted ZINGS and included recruitment in every service and advocacy activity that they hosted. Hopefully, clubs will continue to implement the strategies developed in their long-range plans to continue to recruit and retain their members.

All in all, this biennium clubs in Zonta District 3 Area 2 moved forward in fulfilling Zonta International's vision of "... a world in which women's rights are recognized as human rights and every woman is able to achieve her full potential."

In closing, I would like to thank Area 2 presidents for their support, their participation in the conference calls, and for all that they do to help their clubs thrive and uphold Zonta's mission and vision. A big thank you to our incredible Governor Donna Clark and Lt. Governor JoAnne Gallos for their impeccable leadership this biennium.

## SPOTLIGHT ON AREA 3 - Jan Bryant



**Zonta Club of Annapolis** – The club held its first Designer Bag Bingo fundraiser in April. The event was held at the Elks Club in Annapolis. The event was well attended and the club raised enough funds to support its scholarships. Given its success, the club is considering making this an annual fundraiser event. On the legislative front, many of the bills that the club supported through its membership in MLAW, passed the General Assembly and became law. The club seems to be revitalized and it is attracting interest through its advocacy work. The club plans to have its annual picnic in June.

**Zonta Club of Cumberland County** – The club is currently doing a sub sale fundraiser for the benefit of its scholarship fund. The club awards one scholarship to a senior in high school who plans to attend the local county college and two scholarships to students graduating from Cumberland County College to further their education at a four year school. The club has also donated to Omni's Home in India to support an orphanage founded by one of its members. The club has paid for a well to provide fresh drinking water and an indoor bathroom to make it safer for women. At the club's last meeting, the guest speaker was a nurse who discussed End of Life preparations. The club plans to have an end of year social in June in Ocean City and briefly discuss plans for next year.

**Zonta Club of Harrisburg-Hersey** – The club held its election and installed new officers and directors for 2018-2019. In March, the club visited with women who are the wives of International Fellow Program Students at the US Army War College in Carlisle, PA. Representatives from Albania, Bulgaria, Canada, Georgia, Germany, Moldova, Nepal, Panama, Romania and Sweden were present. All women were presented with a yellow rose to commemorate International Women's Day on March 8. Additionally, the club members prepared decorated shoe boxes with special welcoming gifts for the women who enter Shalom House. The shoe boxes were filled with toiletries, jewelry, scarves, lipstick and other items. The club has significant high performers and a newly elected Zonta Committed Board.

**Zonta Club of Mid-Maryland** – This club has been very busy in the past three or more months. In March, the club, along with its sponsor Senator Joanne C. Benson, hosted a Zonta Day in Annapolis held at the Miller Senate Office Building. The club was introduced by Senator Benson in the State Senate Chambers and recognized in the State Delegate Chambers. This presented an opportunity for the club to advocate for women and girls in Maryland. The club extended an invitation for other Maryland clubs to participate in the event. Unfortunately, no other club sent a representative to this very insightful event. In April, the club, in conjunction with The Prince George's Human Trafficking Task Force, The Maryland Commission for Women and the Prince George's Commission for Women hosted "A Symposium on Human Trafficking: Moving from Awareness to Action." The event drew a great audience and had two surprise visitors: Craig Moe, the mayor of Laurel and Congressman Anthony Brown. Finally, in May, the club provided Zonta Care Boxes to young mothers who visit the family Justice Center located in Upper Marlboro, MD.

**Zonta Club of Philadelphia** – The club hosted its first donation drive in honor of International Woman's Day. The outpouring of support for its members and the community made it possible to collect over 100 items that were used to create housewarming baskets for the club's service partner, Laurel House. The baskets will be distributed to families as they leave the emergency shelter to begin their new life. In April, the club participated in the Going Global Conference in Exton PA. The conference's focus was to educate women and minority business owners about networking and other opportunities. The club's president gave a presentation about Zonta Club of Philadelphia's mission, service and opportunities. As a result of the club's participation in this event, it received three membership inquiries and one scholarship inquiry.

**Zonta Club of Tri-County** – The club had a clothing drive to collect for women and children. The club donated to Big Brothers and Big Sisters of Burlington County. The club is happy to announce that it has increased its membership by one bringing its total membership to four members.

## SERVICE - Jennifer Christensen

Greetings District 3 Zontians!

As the District Service Chair, I would like to remind the Clubs of the Zonta International Service Committee guidelines for district and club service projects:

1. A service project should meet the following criteria:
  - a. It must focus on Zonta's mission
  - b. It must benefit women or girls on the local or district level
  - c. It must address one or both of the following factors:
    - i. empowerment of women in general to achieve equal rights and secure their access to legal, political, economic, educational, health and professional resources
    - ii. prevention of violence against women and girls.
2. A service project is an activity carried out by Zonta members in which they participate actively and personally in organizing and giving 'hands-on' service, not only providing fundraising for the project.
3. It can be a 'once only' project or be ongoing.
4. A hands-on service project may be partnered with another like-minded organization or organizations in accordance with the Affiliation with Other Organizations policy and guidelines.
5. An advocacy aspect is desirable.
6. Zonta's credibility must be protected.

The project should give visibility to Zonta and have wide media coverage, especially in terms of the beneficiaries. (From Criteria for Clubs and Districts to Select a Service Project, June 2017, in Tools section of zonta.org.)

## ADVOCACY - Bobbee Cardillo

Working with Donna and all of the club Advocacy Chairs over the past biennium has been so rewarding for me! Thanks to all of you who created new advocacy activities for your club and participated in District and national advocacy actions with Zontians from other clubs.

Highlights at the Club level included the rally staged by the **Harrisburg-Hershey** club at the PA state capitol to advocate for legislation against human trafficking and participation by **Mid-Maryland** Zontians in a day at the MD legislature advocating against early marriage. **Hampton Roads** hosted a wide-ranging panel on human trafficking during the 16 Days of Advocacy and Zontians from Annapolis joined the Maryland Legislative Agenda for Women and contacted their state representatives every few days while the legislature was in session regarding bills to assist victims of domestic violence and sexual assault.

The **Fairfax** club worked with GMU students to show the film SOLD and presented information about the ZI project in Nepal against human trafficking, while the **Peconic Bay** club promoted the Let Us Learn Madagascar project to friends and family.

In **Philadelphia**, members wore orange wristbands on the 25th of each month in support of the UN's Orange Day against VAW, while in New York, members were active in support of **New York** for CEDAW. **Charles County** set formal advocacy goals and strategies for the year. And several clubs, including **Fairfax, Westchester and New York** sent letters to their Senators and Congressmen in support of the SOAR to Health and Wellness Act.

At the District level members from **Washington, Annapolis, Prince Georges and Fairfax** helped make the District 3 Advocacy Day a big success, either by visiting legislators to advocate for IVAWA, or by helping Sophie Kruz host a screening of her documentary LITTLE STONES for congressional staff. Even our District Conference included a focus on advocacy, with a keynote speaker from End Rape on Campus.

District 3 members also took on advocacy at the national level by supporting the first Zonta Advocacy Day on Capitol Hill during the North American InterDistrict Meeting. Members from **Fairfax, Washington and Mid-Maryland** helped with logistics which enabled 146 Zontians from 30 states to advocate with their Senators and Representatives for the Campus Accountability and Safety Act and the Equal Rights Amendment legislation.

**Policies and Guidelines**

Due to the new European General Data Protection Regulation (GDPR) that is in effect beginning 25 May 2018, the ZI Data Protection Policy, ZIF Data Protection Policy and the Privacy Policy have been updated to comply with the new rules. Data Protection Guidelines are new and have been created to assist members with more details about the practical approach.

All these policies and guidelines will be posted on the Zonta International website latest 25 May. There will be an email distributed to members with this information. Zonta's Privacy Policy can also be used as a template for districts and clubs who need to do an update in order to be compliant.

Both The Affiliation with Other Organizations Policy and Guidelines have also been updated to clarify the difference between various types of affiliations. The category 'Participation' has been added to address Zonta member participation in actions or movements.

**Share Your Story Festival**

Thanks to all clubs that have submitted almost 200 club projects to be presented from the stage at Convention. # AMELIA EARHART - Sharon Jones

---

This has been a memorable Amelia Earhart 2016/2018 biennium. 80 years after Amelia's plane was lost in the Pacific, it remains one of the great unsolved mysteries. Conspiracy theories explaining her disappearance continue to surface: "Amelia Earhart: The Lost Evidence" documentary theorizes that she survived her final flight after crash landing in the Marshall Islands. The aviator was then captured by the Japanese military and died in their custody. A photograph shows Earhart, her navigator Fred Noonan and their ill-fated plane after the crash, is presented as a critical piece of evidence. (This has been refuted by a number of experts). Another theory is that Earhart died a castaway after landing her plane on the remote island of Nikumaroro, 1200 miles from the Marshall Islands. Some 13 human bones were found on Nikumaroro, aka, Gardner Island 3 years after Earhart's disappearance. Forensic analysis suggests the bones could very well have been those of Amelia Earhart. The bones were subsequently lost. A new search for other bones on the island was recently launched. The 81 year unsolved mystery continues and the conspiracy theories continue to unfold.

The goal of Amelia Earhart (AE) Fellowship established in 1938, by Zonta International, in honor of famed pilot and Zontian, Amelia Earhart; is to assist the future of women in the fields of Aerospace Related Sciences and Engineering. The US\$10,000.00 Fellowship is awarded annually to 35 women pursuing Ph.D./doctoral degrees in aerospace-related sciences or aerospace-related engineering. Fall is the time to make your connections with colleges and universities that offer those doctoral degrees: and encourage eligible women to apply for the Amelia Earhart Fellowship.

2019 Amelia Earhart Fellowship application deadline is **November 2018**.

January is Amelia Earhart month, 11th of January is Amelia Earhart Day.
